Notes:

(1) Each month small revisions to figures may have been made since the previous press release. This reflects additional information received.

(2) Industry funds under management includes money invested in the underlying funds in which funds of funds invest, but excludes money invested in funds of funds themselves (other than funds of overseas funds) to avoid double-counting.

(3) ISA figures are based on information from fund managers and five fund platforms that provide data to The Investment Association. These are Cofunds, Fidelity, Hargreaves Lansdown, Skandia and Transact. The figures do not include business through other ISA providers such as wealth managers.

(4) ISA figures exclude a small number of funds held on fund platforms but not in an ISA. These are, however, included in Table 6 and all relevant tables in The Investment Association's monthly press release, unless otherwise footnoted.
